Virtual Medical Assistants wear many hats. The nature of their roles is diverse, ranging from facilitation to management to support.



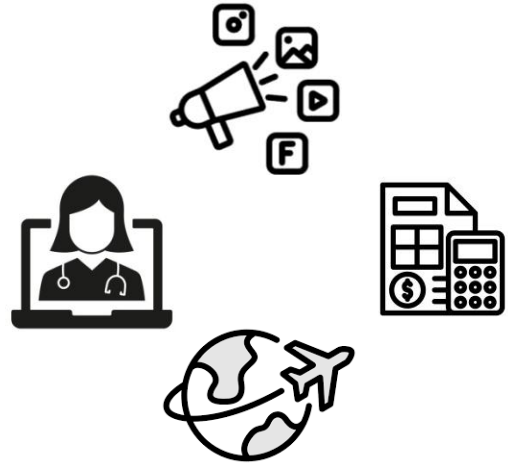
